How will returns impact my Eligibility?

As always, your Title is based on your month-to-month activity. Any returns processed from November 2023 to July 4th, 2024 can impact your title. For example, someone returning an item on July 2nd, 2024 will be deducted from your June qualifications. You will want to be sure to have a buffer and be aware of any last-minute returns to ensure you are on track to earn the Incentive Trip.
